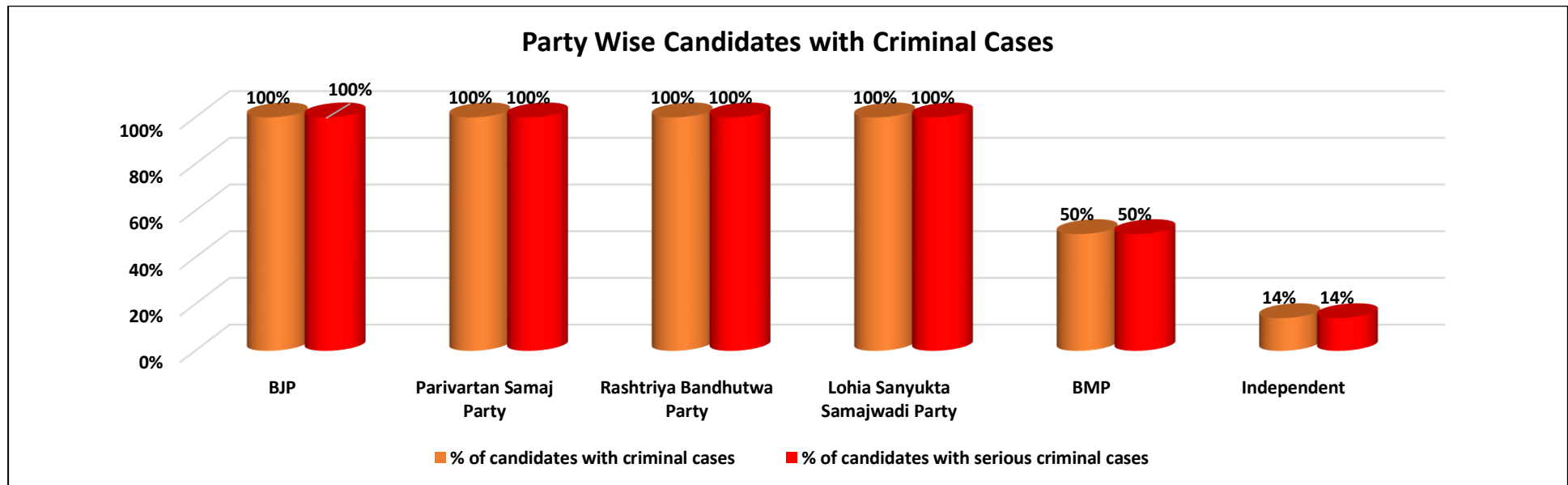
रिपोर्ट के मुख्य अंश

उत्तर प्रदेश इलेक्शन वॉच और एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स ने निर्वाचन क्षेत्र फूलपुर और गोरखपुर लोकसभा उपचुनाव में चुनाव लड़ने वाले सभी **32 उम्मीदवारों** के शपथ पत्रों का विश्लेषण किया। निर्वाचन क्षेत्र फूलपुर और गोरखपुर लोकसभा उपचुनाव उत्तर प्रदेश की मतदान तिथि 11 मार्च 2018 है।

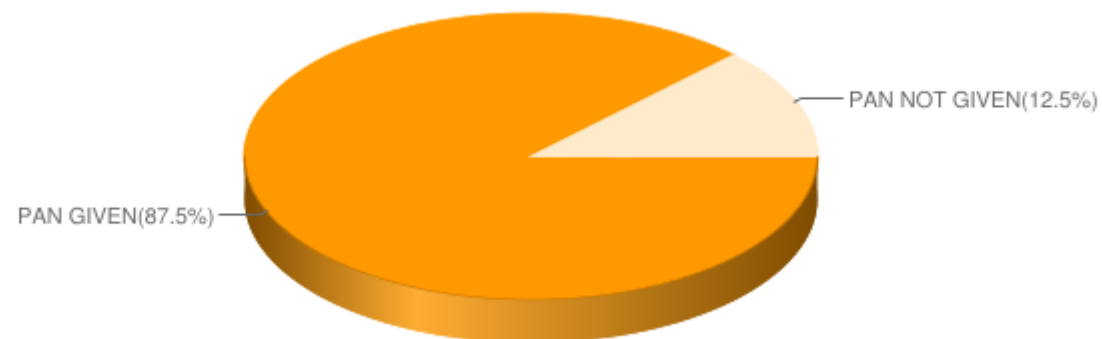

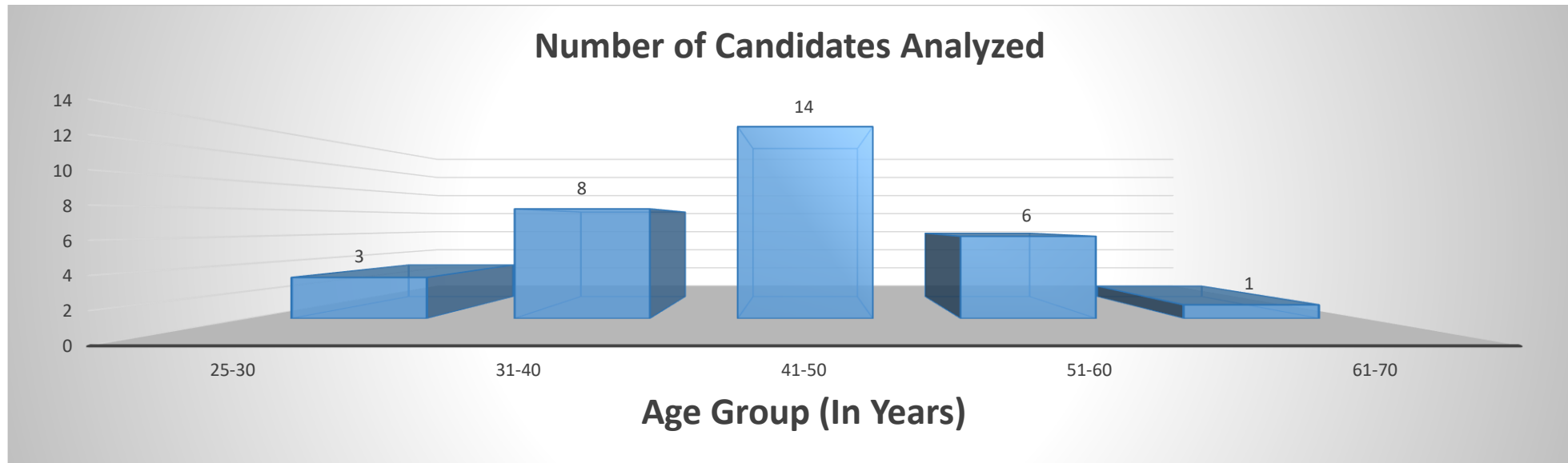

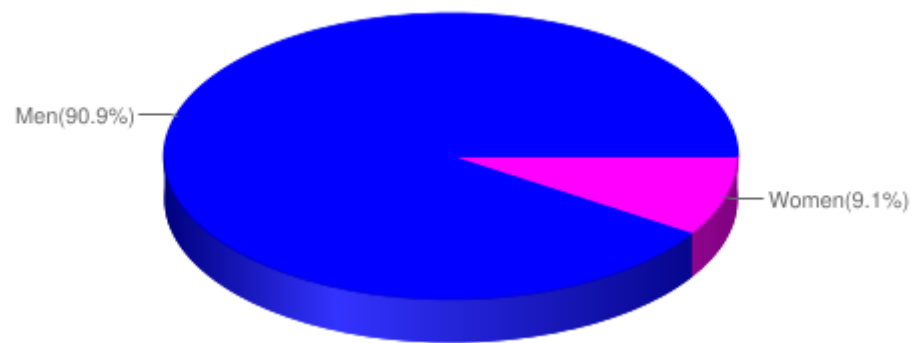
